Welcome to the San Ramon Valley Unified School District Board of Education meeting. Your interest in our schools is greatly appreciated.

Closed Session: Closed session meetings are not open to the public. By law, matters dealing with students and district employees are reserved for closed session to provide confidentiality. Other closed session topics can include litigation, property negotiations, and collective bargaining issues with employee associations. Members of the public are given the opportunity to speak regarding closed session items prior to the closed session.

Open Session: Meetings of the Board of Education are held for board members to conduct the district's business in public. During board meetings, board members have opportunities to recognize individuals for exemplary accomplishments, to review reports from staff, employee groups, and partnership organizations, to discuss district policies and goals, and to act on items that need formal approval. Open session is audio and video recorded.

Individuals who wish to speak before the Board of Education are asked to submit a speaker card to the Board Secretary indicating the item that you wish to address. The Board President will call you forward when the item is introduced. If you are not speaking on a particular agenda item, the Board President will recognize you under non-agenda Public Comment. All comments must be limited to three minutes. By law, board members can only discuss items that are actually on the agenda. For this reason, board members do not engage in dialogue with individuals speaking during the non-agenda public comment section of the meeting. For individuals who wish to speak with board members in depth about an issue, contacting board members on an individual basis is recommended, although individual board members have no legal authority to make decisions without consideration by the whole board.

Action items are considered and voted on individually by the board. **Consent items** are considered routine in nature and are approved by combining them into a single vote. A member of the Board of Education or a member of the public may request that a consent item be removed from the consent agenda and voted on separately.

Copies of board agenda backup and other informational materials provided to members of the Board of Education are available for review in the Office of the Superintendent beginning at 4:00 PM on the last working day of the week preceding each meeting of the Board of Education. Revisions Due to the Adoption of the State Budget

Revenues

Local Control Funding Formula/Other State –

LCFF funds increased \$222,390 based on our final ADA from 2018-19.

New Special Education Preschool funds increased revenues by \$1,570,625.

Routine Budget Revisions

Revenues

Local Control Funding Formula/Other State –

Lottery projections have increased \$3 per ADA, resulting in an additional \$65,238 in unrestricted revenue and \$32,598 in restricted revenue.

Parcel Taxes increased \$85,104.

Federal Revenues –

A grant award of \$71,889 was received for Special Education services.

Other local Revenues –

Local Donations have increased \$ 47,550.

Expenditures

Salaries and Benefits –

Salaries and benefits are increased \$469,967 because of an increase of four (4) certificated positions.

Supplies/Services –

Supplies and services are increased \$333,268 primarily because of budget increases for supplies to sites.



A District may request a PIP only after a diligent search has been conducted and a fully credentialed teacher could not be found.

All requests for a PIP must be presented to the Governing Board of a public school district for approval as an action item on the agenda. Every PIP request that is submitted to the Commission on Teacher Credentialing must also include verification that a notice of intent to employ the named applicant in the identified position has been made public.

WHEREAS good attendance is essential to student achievement and graduation, and we are committed to dedicating our resources and attention to reducing chronic absenteeism rates, with a focus starting as early as prekindergarten and kindergarten,

WHEREAS chronic absence – missing 10 percent or more of school for any reason including excused and unexcused absences, or just two or three days a month – is a proven predictor of academic trouble and dropout rates,

WHEREAS improving attendance and reducing chronic absence takes commitment, collaboration and tailored approaches to particular challenges and strengths in each community,

WHEREAS chronic absence predicts lower third-grade reading proficiency, course failure and eventual dropout, it weakens our communities and our local economy,

WHEREAS the impact of chronic absence hits low-income students particularly hard if they don't have the resources to make up for lost time in the classroom and are more likely to face systemic barriers to getting to school – such as unreliable transportation, lack of access to health care, unstable or unaffordable housing,

WHEREAS attendance gaps among groups of students often turn into achievement gaps that undermine student success. Chronic absence particularly exacerbates the achievement gap that separates low-income students from their peers, since students from low-income families are both more likely to be chronically absent and more likely to be affected academically by missing school.

WHEREAS absenteeism also undermines efforts to improve struggling schools, since it's hard to measure improvement in classroom instruction if students are not in class to benefit from them,

WHEREAS schools and community partners can reach out more frequently to absent students to determine what barriers they face to attending school and what would help them attend more regularly,

WHEREAS health care providers can share the importance of school attendance with families and can offer proactive, preventive care to reduce absences.

WHEREAS schools and districts must do more to track, calculate and share the data on how many students are chronically absent so that we can see the attendance gaps and can deliver the right interventions to the right students,

WHEREAS all students – even those who show up regularly – are affected by chronic absence because teachers must spend time reviewing for students who missed lessons,

WHEREAS chronic absence can be significantly reduced when schools, families and communities work together to monitor and promote good attendance and address hurdles that keep children from getting to school,

NOW, THEREFORE BE IT RESOLVED that as the Board of Education of San Ramon Valley Unified School District, we proclaim our school district will stand with the nation in recognizing September as "Attendance Awareness Month." We hereby commit to focusing on reducing chronic absenteeism to give all children an equitable opportunity to learn, grow and thrive academically, emotional and socially.

**RESOLUTION NO. 7/19-20 IN SUPPORT OF DYSLEXIA AWARENESS MONTH
OCTOBER 2019**

WHEREAS, dyslexia is defined as a specific learning disability that is neurobiological in origin and is characterized by difficulties with accurate and/or fluent word recognition and by poor spelling and decoding abilities, that are often unexpected in relation to other cognitive abilities and the provision of effective classroom instruction.

WHEREAS, dyslexia typically results from a deficit in the phonological component of language which causes difficulty in getting to the individual sounds of spoken language, which affects the ability of an individual to speak, read, spell, and often, learn a language;

WHEREAS, secondary consequences of dyslexia may include problems in reading comprehension and reduced reading experience that can impede growth of vocabulary and background knowledge

WHEREAS, dyslexia is the most common learning disability and affects 80 to 90 percent of all individuals with a learning disability;

WHEREAS, individuals with dyslexia have strengths in higher level cognitive functions, such as reasoning, critical thinking, concept formation, or problem solving;

WHEREAS, great progress has been made in understanding dyslexia on a scientific level, including the epidemiology and cognitive and neurobiological bases of dyslexia; and

WHEREAS, early identification of dyslexia is critical for ensuring that individuals with dyslexia receive focused, evidence-based intervention that leads to the promotion of self-awareness and self-empowerment and the provision of necessary accommodations so as to ensure school and life success:

**RESOLUTION NO. 15/19-20 IN SUPPORT OF WORDS MATTER WEEK
FEBRUARY 3 - 7, 2020**

San Ramon Valley Unified School District supports the goals and ideals of Words Matter Week. By bringing attention to name-calling of all kinds and providing schools, students, and parents with the tools and inspiration to launch an ongoing dialogue about ways to eliminate name-calling and bullying in our schools and in our community, the schools of the SRVUSD will be a safe place to learn for all students.

WHEREAS, No Name-Calling Week, renamed “Words Matter Week” in the San Ramon Valley, is an annual week of educational activities aimed at ending name-calling of all kinds and providing schools with the tools and inspiration to launch an ongoing dialogue to eliminate name-calling and bullying in their communities;

WHEREAS, 60 organizations, including the National School Boards Association, National Association of Elementary School Principals, National Association of Secondary School Principals, National Education Association, National Association of School Psychologists, Gay, Lesbian and Straight Education Network, and Big Brothers Big Sisters of America, have come together as No Name-Calling Week partner organizations;

WHEREAS, our district-wide participation began in 2014 with the name change to “Words Matter Week” adopted in 2015;

WHEREAS, the Gay, Lesbian and Straight Education Network has conducted and released national studies analyzing the pervasive harassment and victimization faced by elementary students and lesbian, gay, bisexual, and transgender (LGBT) secondary students;

WHEREAS, victims of intimidation, harassment, and bullying behaviors perform poorly in school and have a higher rate of school absenteeism;

WHEREAS, over 70 percent of LGBT middle and high school students frequently hear homophobic remarks and over 74% percent of LGBT middle and high school students have been verbally harassed in the past year because of their sexual orientation;

WHEREAS, more than one-third of adolescents, nationally, reported being bullied based on their race or ethnic background;

WHEREAS, threatening words and taunting behavior regarding one's appearance, ethnicity, race, language, gender, size, and/or special learning needs negatively impacts a student's ability to perform scholastically and leaves a child feeling unsafe in an environment where all children should feel a heightened level of safety;

WHEREAS, students with disabilities are two to three times more likely to be bullied than their non-disabled peers;

WHEREAS, 1 out of every 4 students, nationally, reported being bullied or called names at some point while in school;

WHEREAS, between November 9 and December 12, 2016, over 1000 reports of bias-related harassment and intimidation were reported to the Southern Poverty Law Center, with 226 of them occurring in the K-12 environment;

WHEREAS, during the current school year, two of our district high schools have contended with incidents of race-related graffiti;

WHEREAS, the district is involved in a number of efforts to address these concerns and to ensure that all students feel safe at school, including continued expansion of implementation of Culturally and Linguistically Responsive (CLR) Teaching and Learning strategies in all 36 schools, continued special assignment of a teacher working as an equity coach, shifting the focus of our District Climate Committee to four action groups addressing CLR, Inclusion, Equity and Respect, the recent formation of an Equity Task Force with 30 members representing parents, teachers, administrators, students and community members, and investigation of a source of appropriate staff training in how to respond to issues of racism and discrimination.

WHEREAS: Drug overdose deaths are the leading cause of injury death in the United States¹ and are highest among people aged 25 to 54 years;² and

WHEREAS: Most teenagers who abuse prescription opioid drugs get them for free from a friend or relative – but those at highest risk of overdose are as likely to get them from a doctor’s prescription³; and

WHEREAS: In 2018 in Contra Costa County there were 641,374 prescriptions given to patients for opioids which is an age-adjusted rate of 481.5 prescriptions per 1,000 residents which is higher than the state rate of 456.9⁴; and

WHEREAS: Among the more than 74,200 drug overdose deaths estimated nationally in 2017, the sharpest increase occurred among deaths related to fentanyl and fentanyl analogs (synthetic opioids) with over 28,000 overdose deaths⁵; and

WHEREAS: In 2017 47,600 Americans died from opioid overdoses, an average of 130 people every day¹ and in 2018, 81 Contra Costa County residents died from an opioid overdose⁴; and

WHEREAS: As many as 1 in 4 people who receive prescription opioids long term for non-cancer pain in primary care settings struggles with opioid addiction²; and

WHEREAS: Each day, more than 1,000 people are treated in emergency departments for not using prescription opioids as directed²; and

WHEREAS: in 2017 it is estimated that America’s opioid epidemic exacted at least \$504 billion in economic costs related to health care, crime and lost work productivity¹; and

WHEREAS: Americans that have participated in DEA’s seventeen National Prescription Drug Take-Back Days have turned in more than 4,508 tons of medication over the past nine years at take-back sites available in all 50 states and U.S. territories⁶, and in Contra Costa County, during the April 2019 DEA sponsored Take-Back Day, 1,628.2lbs of unwanted or unused prescription medication were removed; and




